

KIDS FASHIONS ON THE FIELD

TERMS & CONDITIONS

Conditions of entry

You must check in at the Fashions on the Field Stage between 11.30am and 12:00pm. Judging will take place following the running of the River 94.9FM Dad's Bod Bolt at approximately 12:15pm.

The total number of entrants is limited to 50 in each category and will include the first 50 entrants to nominate/register.

Judging criteria will be based on age appropriateness, seasonal suitability, originality, deportment skills, smile and overall presentation. It is a competition in good faith and good fun. It is anticipated every child will receive a ribbon for participation.

1. **Judging criteria:** Entrants will be provided a Fashions on the Field ID number. This ID number must be shown during judging. Entrants will be judged in three categories.

Category 1 – Most Fashionable Tiny Tots under 5 years old

Category 2 – Most Fashionable 5-12 year old

Category 3 – Most Fashionable 12-17 year old

Judging criteria will be based on age appropriateness, seasonal suitability, originality, deportment skills, smile and overall presentation. It is a competition in good faith and good fun.

Proof of age may be required. A guardian or parent must accompany the child for the event and be present throughout the judging. The guardian or parent must provide authority for the entrant to be photographed for use in marketing materials produced by the Ipswich Turf Club.

Contestants agree that their image, name, character, likeness, voice or anything else that identifies them for the purposes of any promotion or matter incidental to the Promotion, including future similar promotions, and at any time during or after the Promotional Period and via any means (including but not limited to, any national print media, the Promoter's website and any other promotional material) may be used by the Promoters, and the Promoters' sponsors for future promotional and publicity purposes without any compensation or reward.

Prizes: The prize list will be announced shortly.

All prizes are valued inclusive of GST and the Promoter Ipswich Turf Club takes no responsibility for any variation in item values. Any taxes which may be payable as a consequence of a winner receiving the prize are the sole responsibility of that winner. Prizes are non-transferable and may not be redeemed for cash. If the specified prize becomes unavailable due to unforeseen circumstances, the Promoter may substitute a prize of similar nature and/or like or greater value.

- 2. **Competition Duration:** The competition commences at 12pm Sunday 6 June 2021. See 1 Method of Entry for closing time of entries. All entrants must attend the stage located in the forecourt near the main entrance.
- 3. **Eligibility Limitations:** Entrants who miss the preliminary judging will not be eligible for the final judging. Entrants who do not arrive in time for either the preliminary or final judging will be disqualified.

The following persons are ineligible to enter:

- (i) Employees of, or contractors to, the Promoter so far as they are directly associated with this competition.
- (ii) The spouse, de facto spouse, parent, natural or adopted child, and sibling (whether natural or adopted), of such employees and contractors (whether or not they live in the same household).
- (iii) Contestants who have used or attempted to use any more than one name in order to qualify to win any contest run by the promoter except in the case of a legal change of name.

All contestants acknowledge that even if the Promoter only learns of a person's ineligibility after the Promoter has appeared to award the prize to the ineligible person, it may require the return of the prize or payment of its value to the Promoter to be dealt with as an unclaimed prize.

4. **Winners and notification:** The winning entrants will be announced at approximately 12.30pm on Sunday 6 June 2021 at the Ipswich Turf Club. Winners will be judged by individual judges and based on the following selection criteria:

Judging criteria will be based on age appropriateness, seasonal suitability, originality, deportment skills, smile and overall presentation. All winners must collect their prize on day of the event. Judge's decision is final and no correspondence will be entered into. All contest winners must avail themselves for a photo if required by the Promoter and acknowledge that the Promoter has the right to utilize publicity photos in any reasonable manner it sees fit without compensation to the client.

- 5. Prize collection: All winners must collect their prizes on the day. Gift Card Prizes must be used by the date indicated on the back of the card. Upon request by the Promoter a copy of the general contest rules and/or a signed receipt and acknowledgement must be signed and endorsed by the winner to understand his/her understanding and acceptance of those terms.
