TERMS & CONDITIONS

Conditions of entry:

Registrations will be available on the day at the Fashions on the Field Registration table located at the Main Stage between 11.30am and 12.30pm.

All entrants must have a paid ticket/entry into the racecourse on the day in order to qualify for entry into the competition.

1. **Method of entry:** Upon entering, contestants agree to be bound by these terms and conditions.

Registrations may be made on the day, 15 June 2019, between 11.30am and 12.30pm on site at the Fashions on the Field registration table inside the premises of the Ipswich Turf Club, 219 Brisbane Road, Bundamba.

The total number of entrants is limited to 50 in each category and will include the first 50 entrants to nominate/register. Terms and conditions are found at www.ipswichturfclub.com.au

2. **Judging criteria:** Entrants will be provided a Fashions on the Field ID number. This ID number must be shown during judging. Entrants will be judged in three categories.

Category 1 – Most Fashionable Female
Category 2 – Best Dressed Male
Category 3 – Finest Couple

Judging criteria will be based on seasonal suitability, originality, choice of headwear, accessories, attention to detail, deportment skills and smile, overall presentation, elegance etc. Up to 8 female finalists, 8 male finalists, and 8 couple finalists will be selected for the finals.

Prizes: The prize list will be announced shortly.

All prizes are valued inclusive of GST and the Promoter Ipswich Turf Club takes no responsibility for any variation in item values. Any taxes which may be payable as a consequence of a winner receiving the prize are the sole responsibility of that winner. Prizes are non-transferable and may not be redeemed for cash. If the specified prize becomes unavailable due to unforeseen circumstances, the Promoter may substitute a prize of similar nature and/or like or greater value.

3. **Competition Duration:** The competition commences at 1pm Saturday 15 June 2019. See 1 – Method of Entry for closing time of entries. All entrants must attend the preliminary judging commencing at 1pm which will be held on the main stage area located in the forecourt near the main entrance on Saturday 15 June 2019 to be eligible for prizes. Final judging will take place at approximately 2pm on stage at Ipswich Turf Club on Saturday 15 June 2019. Judging will not commence until course officials allow such.
4. **Eligibility Limitations:** Entrants who miss the preliminary judging will not be eligible for the final judging. Entrants who do not arrive in time for either the preliminary or final judging will be disqualified. Contestants must be at least 18 years of age to enter.

The following persons are ineligible to enter:

- (i) Employees of, or contractors to, the Promoter so far as they are directly associated with this competition.
- (ii) The spouse, de facto spouse, parent, natural or adopted child, and sibling (whether natural or adopted), of such employees and contractors (whether or not they live in the same household).

Judging criteria will be based on seasonal suitability, originality, choice of headwear, accessories, attention to detail, deportment skills and smile, overall presentation, elegance etc. All winners will be contacted by 30 June 2019 to advise on the collection of prizes. Judge's decision is final and no correspondence will be entered into. All contest winners must avail themselves for a photo if required by the

Promoter and acknowledge that the Promoter has the right to utilize publicity photos in any reasonable manner it sees fit without compensation to the client.

6. **Prize collection:** All winners will be contacted by June 30, 2019 to advise on the redemption of the Gift Card prizes.
